In addition, I agree to notify Riverside Golf Course of any changes to my payment information at least 10 days prior to the next payment authorization period. If my card declines for any reason, I will provide an alternative method of payment within two (2) business days of notification. If payment is not received by the 10<sup>th</sup> of any month, a \$25.00 late fee is assessed in addition to suspension of privileges. Payments not brought current by the 28<sup>th</sup> of any month will result in termination of annual pass.

### Agreement and Signature

By signing, I affirm that all information provided is in truth and honesty. I understand and agree that any violation of rules or policies set forth is grounds for immediate termination of this agreement. Agreement can be canceled by pass holder with written notice within the first 90 days of calendar year. New agreements signed after this 90-day period will not have a cancelation option. If agreement is paid in full at beginning of term, cancelations will be refunded a prorated portion remaining term. If Notwithstanding other provisions in this Agreement relating to term, Riverside Golf Course may terminate the Agreement without cause upon at least 30 days written notice.
